PARTIAL MODIFICATION

The following partial modification is declared in the results for the Posts of Assistant Environment Engineer (Advt.2017-18/2) declared on 09/08/2019

- (1) In Annexure- A (List of successful Candidates for the appointment) Merit No.26, Mr. Vivek Paresh Kapadia (General) actually obtained final total marks 53.16, but inadvertently considering 54.16 marks declared successful candidate for appointment. As such, now his name is deleted at Merit No.26 and placed at Merit No. 4-A in the list of candidates kept on waiting List.
- (2) In view of above change, in Annexure-A (List of successful Candidates.....) Merit No. 27 Mr. Bhargav Dayabhai Gohil declared successful candidates in the category of SEBC. But considering his total marks, he has secured the qualifying standards of General category and not availed any relaxations, now he is consider as General Category candidate.
- (3) In Annexure-A (List of successful candidates for appointment) in regard to Merit No. 28 Mr. Bhavesh Dhanjibhai Chorwadi (SEBC), it is revealed that he has obtained B.E. (Environment Engineering) degree on 21-6-2018, whereas the Last date for submission of the application was 10-11-2017. Therefore, he was not possessing the requisite educational qualification on the last date of submission of the application. In accordance with the provision of 8(1) of the common instructions of the advertisement, his candidature is hereby cancelled and entry at Merit No.28 is deleted.

- (4) As per above para (2) and (3), two more SEBC candidates required to be included in the list of successful candidates for appointment. The SEBC candidates kept on waiting list at Merit No. 15 and 16 are now declared as successful candidates for appointment and placed at Merit No. 41-A and 41-B respectively.
- (5) Para 3(iii), Six and Seventh line read as " Merit No.3,5,16,18,22,25 and 27 = 7 candidates" instead of "Merit No.3,5,16,18,22 and 25= 6 candidates".
- (6) Para 3 (iv) is revised as under :
"Physically disabled in all Eight (06–Unreserved and 02–SEBC) candidates called for Interview test and they remained present. They have not been selected under their respective category in the qualifying standard fixed for such category. As such they have been considered by applying relaxation of 10% marks of the respective category. The Cut of marks derived for General category is 54.12 marks. Than after subtracting 10% marks is derived i.e. 48.71 marks (i.e. $54.12 - 5.41 = 48.71$). The Cut of marks derived for S&EBC category candidates is 46.66 marks. Than after subtracting 10% marks is derived i.e. 42.00 marks (i.e. $46.66 - 4.66 = 42.00$). The General disabled male six candidates (Roll NO. 2000475, 2000766, 2002438, 2003956, 2004671, 2004854) and two S&EBC disabled male candidates (Roll No. 2000048, 2004204) have not attained the qualifying standard and therefore none candidates is selected".
